Section 4. First Aid Measures

Fire & Explosion hazards: Hydrochloric acid is a negligible fire hazard when exposed to heat and/or flames. Hydrochloric acid may react with the evolution of heat on contact with water; the acid may release toxic, corrosive, flammable, or explosive gases.

Extinguishing Media: Use regular dry chemical, carbon dioxide, water, or regular foam.

Specific Methods: Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

Section 6. Accidental Release Measures

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Do not allow to enter drainage systems or water ways. Dike area and dilute spill with water and neutralize with soda ash, limestone, etc. Place the neutralized material into containers suitable for eventual disposal, reclamation, or destruction.
